Sociologists from the previous centuries have warned people about the power and prestige that can affect how a person or a country treats another. There are multiple examples present in our society, and one such example is the Humanitarian Refugee crisis. For the last ten to twenty years, a humanitarian crisis has been an issue. A problem with minimum intensity is enough to disrupt any country's political, social, and economic structure (*What Is a Humanitarian Disaster*? n.d.). A county handling a humanitarian crisis can lead its people to end in violent acts and displacement of people. The 21st century has affected people's lives in many ways, but the refugee crisis has impacted the global population and especially America. According to the research conducted by the UNHCR, America has been a flag bearer of accepting refugees since 2010 (*Humanitarian Emergencies Around the World | USA for UNHCR*, n.d.). Still, under the Trump administration, 85% of the refugees were denied entrance to the U.S (*An Overview of U.S. Refugee Law and Policy*, 2021). It means that people in power and politics can decide their help. The theory also points out that power and prestige can create discrimination in the people. We collectively live in a society, but bias is presently based on socioeconomic status and power available to certain people (Crossman, 2019).
